**ESSENTIAL ELEMENTS:**

- Performs more complex tasks of plumbing inspections, e.g., reviews plans, drawings and specifications of plumbing installations submitted by architects, engineers, contractors, business owners to ensure compliance with state laws and regulations governing plumbing backflow prevention and drainage.
- Examines permit applications for plumbing installations and determines permit fees.
- Confers with contractors, installers, building owners and provides classroom instruction concerning proper plumbing system installation, backflow and cross connection prevention.
- Performs plumbing inspections and investigations countywide to enforce state codes and county regulations.
- Takes plumbing inspection telephone calls.
- Establishes travel routes, charts status of inspections to ensure all plumbing inspections performed within time prescribed by law.
- Completes inspection reports.
- Completes mileage and expense reports.
- Answers questions concerning plumbing code.
- Prepares routine correspondence regarding work activities.
- Maintains backflow program with the Erie County Department of Environmental Services.
- Maintains files as necessary (e.g., plans reports, mileage, DARs).
- Follows all HIPAA provisions concerning confidential information.
- Participates in the Incident Command Structure according to the NIM system.
- Responds to incident management/emergency issues.
- Completes other special projects or duties as assigned.
- Responds to organizational goals, strategic priorities, and management by objectives (MBOs).

**NON-ESSENTIAL ELEMENTS:**

- Assists with training and orientation of new employees.
- Attends meetings as required.
- Communicates according to situational or organizational structure.
- Notifies supervisor of any treatment which may affect decision making.

Possess Ohio Board of Building Standard plumbing and medical gas inspector certification, Ohio Department of Commerce plumbing inspector certification and Code Academy completion. Participate in the Ohio Construction Licensing Board Continuing Education Program. Seven years practical plumbing experience to include skill and training in matters related to sanitary regulations concerning plumbing work per Section 3703.04 of Revised Code; 1 year experience in inspection of plumbing installation and drainage in accordance with state regulations; maintain Ohio Department of Health Radon Tester's License. Proficient in electronic records and new technology as applied to position. Must maintain a valid Ohio driver's license and current automobile liability insurance throughout employment.
